

GX0011787: HVO HEFA NWE NETHERLANDS PRODUCTION COST MODEL B MAX HVO VS FEEDSTOCK

INDEX DESCRIPTION

These indexes reflect a minimum cost price for Hydrotreated Vegetable Oil (HVO aka Renewable Diesel) produced in North West Europe via the HEFA pathway. The refinery scenario modelled is "Max HVO". Total renewable product yield is 92% (80% HVO, 6% SAF, 3% Bio-Naphtha, and 3% Bio-LPG). It assumes a facility in Rotterdam with 820,000 MT/annum total renewable product capacity. Feedstock is 100% Used Cooking Oil (UCO).
